1 **Chapter 821. TEXAS PAYDAY RULES**

2  
3 **SUBCHAPTER A. GENERAL PROVISIONS**

4  
5 **§821.1. Title and Purpose.**

6  
7 (a) Title. These rules may be cited as the Texas Payday Rules.

8  
9 (b) Purpose. The purpose of these rules is to implement and interpret the provisions of  
10 the Texas Labor Code, Chapter 61, Payment of Wages.

16 **§821.2. Definitions.**

17  
18 The following words and terms, when used in this chapter, shall have the following  
19 meanings, unless the context clearly indicates otherwise.

20  
21 (1) Act--Texas Labor Code, Chapter 61, also known as the Texas Payday Act or  
22 the Texas Payday Law.

23  
24 (2) Claimant--A person who has filed a wage claim under the Act.

25  
26 (3) Commission--The Texas Workforce Commission.

27  
28 (4) Court of competent jurisdiction--A court authorized to issue an order  
29 including, but not limited to, a legislative or statutory county court at law,  
30 district court, small claims court, or federal court that acts within the  
31 appropriate jurisdiction over the amount in controversy, the person, and other  
32 appropriate subject matter.

38 **§821.3. Jurisdiction.**

39  
40 (a) The Commission shall exercise jurisdiction over wage claims in which:

41  
42 (1) the work is performed exclusively in Texas;

43  
44 (2) the work is performed in part in Texas and in part in other states within the  
45 United States and where the wages would be reportable to Texas for

1 Unemployment Insurance purposes pursuant to Texas Labor Code §201.043;  
2 or

3  
4 (3) the work is performed by an individual who is a Texas resident at the time the  
5 work is performed and the work is performed outside Texas for a Texas  
6 employer or a non-resident employer over whom Texas exercises jurisdiction  
7 pursuant to subsection (b) of this section.  
8

9 (b) The Commission shall exercise jurisdiction over a non-resident employer pursuant to  
10 the Texas Civil Practice & Remedies Code, Chapter 17, Subchapter C, also known as  
11 the "Texas Long-Arm Statute," when all three of the following are met:  
12

13 (1) the employer purposely does some act or consummates some transaction in  
14 Texas;

15  
16 (2) the wage claim arises from the employer's act or the employer's contact with  
17 Texas is continuing and systematic; and

18  
19 (3) exercising jurisdiction is consistent with:

20  
21 (A) fair play and justice as determined by the quality, nature and extent of  
22 the employer's activities in Texas including the extent to which the  
23 employer avails itself of the benefits and protections of Texas law; and

24  
25 (B) the relative convenience of the parties.  
26

27 (c) The Commission shall not exercise jurisdiction over wage claims to the extent the  
28 wages are for work performed outside the United States.  
29

34 **§821.4. Political Subdivision.**

35  
36 (a) An entity is a political subdivision of the state, and therefore not an employer under  
37 the Act, if it meets the criteria in either subsections (b) or (c) of this section.  
38

39 (b) An entity is a political subdivision of this state if it is a governmental unit having:

40  
41 (1) the power to tax real and tangible personal property;

42  
43 (2) limited geographic and jurisdictional boundaries;

44  
45 (3) locally elected or locally appointed governing members; and

(4) the authority to provide a general public service or benefit.

(c) An entity is a political subdivision of this state if the entity is so designated by Texas statute.

(d) Entities that are political subdivisions of this state include, but are not limited to:

- (1) cities;
- (2) counties;
- (3) school districts;
- (4) junior college districts;
- (5) levee improvement districts;
- (6) drainage districts;
- (7) irrigation districts;
- (8) water improvement districts;
- (9) water control and improvement districts;
- (10) water control and preservation districts;
- (11) freshwater supply districts;
- (12) navigation districts;
- (13) conservation and reclamation districts;
- (14) soil conservation districts;
- (15) municipal utility districts;
- (16) river authorities;
- (17) housing authorities;
- (18) hospital authorities; and

2 (19) other similar entities.

9 **§821.5. Employment Status: Employee or Independent Contractor.**  
10

11 The Commission adopts the following form, Form C-8, as its official guideline for use in  
12 determining employment status.  
13

**EMPLOYMENT STATUS – A COMPARATIVE APPROACH**

---

Under the common law test, a worker is an employee if the purchaser of that worker's service has the right to direct or control the worker, both as to the final results and as to the details of when, where, and how the work is done. Control need not actually be exercised; rather, if the service recipient has the *right* to control, employment may be shown.

Depending upon the type of business and the services performed, not all 20 common law factors may apply. In addition, the weight assigned to a specific factor may vary depending on the facts of the case.

If an employment relationship exists, it does not matter that the employee is called something different, such as agent, contract laborer, subcontractor, or independent contractor.

---

**1. INSTRUCTIONS:**

An Employee receives instructions about when, where and how the work is to be performed.

*An Independent Contractor does the job his or her own way with few, if any, instructions as to the details or methods of the work.*

**2. TRAINING:**

Employees are often trained by a more experienced employee or are required to attend meetings or take training courses.

*An Independent Contractor uses his or her own methods and thus need not receive training from the purchaser of those services.*

**3. INTEGRATION:**

---

**11. ORAL OR WRITTEN REPORTS:**

An Employee may be required to submit regular oral or written reports about the work in progress.

*An Independent Contractor is usually not required to submit regular oral or written reports about the work in progress.*

**12. PAYMENT BY THE HOUR, WEEK OR MONTH:**

An Employee is typically paid by the employer in regular amounts at stated intervals, such as by the hour or week.

*An Independent Contractor is normally paid by the job, either a negotiated flat rate or upon submission of a bid.*

**13. PAYMENT OF BUSINESS & TRAVEL EXPENSE:**

---

Services of an Employee are usually merged into the firm's overall operation; the firm's success depends on those Employee services.

*An Independent Contractor's services are usually separate from the client's business and are not integrated or merged into it.*

---

**4. SERVICES RENDERED PERSONALLY:**

An Employee's services must be rendered personally; Employees do not hire their own substitutes or delegate work to them.

*A true Independent Contractor is able to assign another to do the job in his or her place and need not perform services personally.*

---

**5. HIRING, SUPERVISING & PAYING HELPERS:**

An Employee may act as a foreman for the employer but, if so, helpers are paid with the employer's funds.

*Independent Contractors select, hire, pay and supervise any helpers used and are responsible for the results of the helpers' labor.*

---

**6. CONTINUING RELATIONSHIP:**

An Employee often continues to work for the same employer month after month or year after year.

*An Independent Contractor is usually hired to do one job of limited or indefinite duration and has no expectation of continuing work.*

---

**7. SET HOURS OF WORK:**

An Employee may work "on call" or during hours and days as set by the employer.

*A true Independent Contractor is the master of his or her own time and works the days and hours he or she chooses.*

An Employee's business and travel expenses are either paid directly or reimbursed by the employer.

*Independent Contractors normally pay all of their own business and travel expenses without reimbursement.*

---

**14. FURNISHING TOOLS & EQUIPMENT:**

Employees are furnished all necessary tools, materials and equipment by their employer.

*An Independent Contractor ordinarily provides all of the tools and equipment necessary to complete the job.*

---

**15. SIGNIFICANT INVESTMENT:**

An Employee generally has little or no investment in the business. Instead, an Employee is economically dependent on the employer.

*True Independent Contractors usually have a substantial financial investment in their independent business.*

---

**16. REALIZE PROFIT OR LOSS:**

An Employee does not ordinarily realize a profit or loss in the business. Rather, Employees are paid for services rendered.

*An Independent Contractor can either realize a profit or suffer a loss depending on the management of expenses and revenues.*

---

**17. WORKING FOR MORE THAN ONE FIRM AT A TIME:**

An Employee ordinarily works for one employer at a time and may be prohibited from joining a competitor.

*An Independent Contractor often works for more than one client or firm at the same time and is not subject to a non-competition rule.*

**8. FULL TIME REQUIRED:**

---

An Employee ordinarily devotes full-time service to the employer, or the employer may have a priority on the Employee's time.

*A true Independent Contractor cannot be required to devote full-time service to one firm exclusively.*

**9. LOCATION WHERE SERVICES PERFORMED:**

---

Employment is indicated if the employer has the right to mandate where services are performed

*Independent Contractors ordinarily work where they choose. The workplace may be away from the client's premises.*

**10. ORDER OR SEQUENCE SET:**

---

An Employee performs services in the order or sequence set by the employer. This shows control by the employer.

*A true Independent Contractor is concerned only with the finished product and sets his or her own order or sequence of work.*

**§821.6. Wage Claims Involving Minimum Wage or Overtime.**

- (a) The Commission shall consider any applicable minimum wage and overtime requirement in determining if wages are due and unpaid.
- (b) In determining an employee's entitlement to federal minimum wage or overtime, the Commission shall look to the Fair Labor Standards Act (FLSA) of 1938 as amended, 29 U.S.C. 201 et seq., and the regulations promulgated by the United States Department of Labor thereunder. In determining an employee's entitlement to state minimum wage, the Commission shall look to the Texas Minimum Wage Act, located at Texas Labor Code, Chapter 62.

**18. MAKING SERVICE AVAILABLE TO THE PUBLIC:**

---

An Employee does not make his or her services available to the public except through the employer's company.

*An Independent Contractor may advertise, carry business cards, hang out a shingle or hold a separate business license.*

**19. RIGHT TO DISCHARGE WITHOUT LIABILITY:**

---

An Employee can be discharged at any time without liability on the employer's part.

*If the work meets the contract terms, an Independent Contractor cannot be fired without liability for breach of contract.*

**20. RIGHT TO QUIT WITHOUT LIABILITY:**

---

An Employee may quit work at any time without liability on the Employee's part.

*An Independent Contractor is legally responsible for job completion and, on quitting, becomes liable for breach of contract.*

6 **§821.7. Notice of Paydays.**

7  
8 For purposes of posting notices indicating an employer's paydays, electronic posting is  
9 sufficient to meet the requirements of §61.012(c) of the Act as long as the electronic  
10 posting otherwise meets the requirements of the Act.

11

16 **SUBCHAPTER B. PAYMENT OF WAGES**

17  
18 **§821.21. Complete and Unconditional Payment of Wages.**

19  
20 (a) An employer has paid an employee's wages for purposes of the Act if the employer  
21 has delivered the wages to the employee:

- 22  
23 (1) in a form authorized by §61.016 of the Act; and  
24  
25 (2) by a method authorized by §61.017 of the Act.

26  
27 (b) An employer has not paid an employee's wages for purposes of the Act if the  
28 employee has received the wages subject to a third party claim because:

- 29  
30 (1) the paycheck has been dishonored due to insufficient funds, a stop-payment  
31 order or any other reason attributable to the employer;  
32  
33 (2) the employer has caused a direct deposit of the wages to be reversed; or  
34  
35 (3) the employer has taken other similar action to undo the payment of wages.

36

41 **§821.22. Payment Other Than on Payday.**

42  
43 (a) For purposes of §61.013 of the Act, the Commission interprets "another regular  
44 business day" to mean any regular business day, which is designated as being such  
45 within the customary practice of the employer, following the employer's designated  
46 payday.

- 1  
2 (b) When an employee leaves employment other than by discharge on a payday,  
3 payment of wages in full will be due the following scheduled payday. The  
4 Commission shall consider "discharge" as dismissal or release from employment  
5 initiated by the employer including, but not limited to, layoff.  
6

11 **§821.25. Fringe Benefits.**  
12

- 13 (a) For purposes of §61.001(7)(B) of the Act, vacation pay and sick leave pay are  
14 payable to an employee upon separation from employment only if a written  
15 agreement with the employer or a written policy of the employer specifically  
16 provides for payment.  
17
- 18 (b) For purposes of §61.001(7)(B) of the Act, severance pay is payment by an employer  
19 to an employee beyond the employee's wages on termination of employment, based  
20 on the employee's prior service. Severance pay does not include payments for  
21 liquidated damages, payments in exchange for a release of claims, or payments made  
22 because of a lack of notice of separation.  
23
- 24 (c) For purposes of §61.001(7)(B) of the Act, the sale of an employer's business is a  
25 termination of employment with all of the employer's employees. At the time of  
26 termination, the employer becomes liable for the payment of vacation pay, holiday  
27 pay, sick leave pay, parental leave pay, or severance pay if owed pursuant to a  
28 written agreement or written policy between the employer and its employees.  
29
- 30 (d) For purposes of §61.001(7)(B) of the Act, expense reimbursements paid to  
31 employees are not wages. Expense reimbursements are payments to the employee  
32 for costs expended by the employee directly related to the employer's business.  
33
- 34 (e) Absent the inclusion of definitions of terms in a written agreement with the employer  
35 or under a written policy of the employer, a term will be given its ordinary meaning  
36 unless a party establishes that it is defined in another way.  
37
- 38 (f) For purposes of §61.001(7)(B) of the Act, accrued leave time of an employee shall  
39 carry over to subsequent years only if a written agreement with the employer or a  
40 written policy of the employer specifically provides for it.  
41
- 42 (g) For purposes of §61.001(7)(B) of the Act, paid time off (PTO) or paid days off  
43 (PDO) are wages unless the employer's written policy defines PTO or PDO as  
44 something other than a combination of vacation pay, holiday pay, sick leave pay,  
45 parental leave pay, or severance pay. PTO or PDO is payable to an employee upon

1 separation from employment only if a written agreement with the employer or a  
2 written policy of the employer specifically provides for payment.

3

8  
9 **§821.26. Commissions or Bonuses.**

10  
11 (a) For purposes of §61.015 of the Act:

12  
13 (1) Commissions or bonuses are earned when the employee has met all the  
14 required conditions set forth in the applicable agreement with the employer.  
15 To change an agreement, there must be prior notice as to the nature and  
16 effective date of the changes. Changes to written agreements shall be in  
17 writing.

18  
19 (2) Commissions or bonuses are due to be paid, in a timely manner, according to  
20 the terms specified in an agreement between an employer and an employee.  
21 The terms should specify the time intervals or circumstances (or combinations  
22 thereof) that would cause commissions or bonuses to become payable, such as,  
23 but not limited to, weekly, monthly, quarterly, when sales transactions are  
24 recorded, upon buyer's remittance, etc.

25  
26 (b) Unless otherwise agreed, the employer shall pay, after separation, commissions or  
27 bonuses earned as of the time of separation.

28  
29 (c) Commissions or bonuses due after separation from employment are payable based on  
30 the routine or practice specified in the agreement when the employee was employed,  
31 or on any special agreement made between the employee and the employer upon  
32 separation.

33  
34 (d) Draws against commissions or bonuses may be recovered from the current or any  
35 subsequent pay period until fully reconciled.

42 **§821.27. Loans.**

43  
44 (a) An employer must comply with §61.018 of the Act and this chapter to recoup a loan  
45 the employer made to an employee, unless the loan is an advance under §821.29.

- 1 (b) In recouping a loan made to an employee, an employer may count the loan  
2 repayment toward any applicable minimum or overtime wages the employer is  
3 obligated to pay to the employee.  
4
- 5 (c) In recouping a loan made to an employee from any of the employee's paychecks,  
6 including the employee's final paycheck, the employer may not withhold or divert  
7 more than the agreed amount. The agreed amount is the amount:  
8
- 9 (1) identified as the amount to be withheld from any one paycheck in the written  
10 loan agreement between the employer and employee; or  
11
- 12 (2) otherwise authorized in writing by the employee for repayment of the loan.  
13

19 **§821.28. Deductions.**  
20

- 21 (a) The Commission provides the following guidance in determining whether an  
22 employer is entitled to withhold or divert wages under court order, by law or with  
23 written authorization under § 61.018 of the Act:  
24
- 25 (1) A court is presumed to be a court of competent jurisdiction with respect to  
26 issuing court orders. The burden shall be on the party opposing a court order  
27 to challenge the court's authority by appealing to the issuing court or court of  
28 appropriate review as the Commission will presume full faith and credit  
29 applies to court orders.  
30
- 31 (2) State or federal law includes statutes and codes enacted by Congress or the  
32 Texas Legislature, rules promulgated by a Texas or federal agency, and  
33 regulations promulgated by a Texas or federal agency.  
34
- 35 (3) A lawful purpose is one that is authorized, sanctioned, or not forbidden, by  
36 law.  
37
- 38 (b) Written authorization for deductions shall be specific as to the lawful purpose for  
39 which the employee has accepted the responsibility or liability. Written  
40 authorizations shall be:  
41
- 42 (1) sufficient to give the employee a reasonable expectation of the amount to be  
43 withheld from pay; and  
44
- 45 (2) a clear indication that the deduction is to be withheld from wages.  
46

- (c) If an employer uses a handbook, policy manual or other similar document instead of a separate writing, the employee's signed acknowledgment of receipt of company policies can be authorization to withhold wages if the acknowledgment meets the requirements of subsection (b) of this section and specifically informs the employee of the deduction. The signed acknowledgment of receipt shall also include language that states that the employee agrees to abide by or be bound to the authorization for deduction.
- (d) The employer shall ensure that properly withheld wages are applied toward their authorized purpose. Properly withheld wages not applied toward their authorized purpose will be considered unlawful deductions.
- (e) The employer shall obtain written authorization as required under the Act to deduct credit card service charges from an employee's tips.

**§821.29. WAGE ADVANCES.**

- (a) A wage advance occurs when an employer advances to an employee a monetary sum that represents wages not yet earned, or wages that have been earned but are not yet due for payment.
- (b) An employer may recoup the wage advance from the employee's next regularly scheduled paycheck directly following the advance if:
  - (1) the employer provides the employee with notice that the amount is an advance that will be recovered from the next paycheck; and
  - (2) the employee agrees to the amount to be recouped.
- (c) If the wage advance is not recouped in the next regularly scheduled paycheck following the advance, the employer shall comply with §61.018 of the Act.

**SUBCHAPTER C. WAGE CLAIMS**

**§821.41. Validity of Claim/Filing and Investigative Procedures.**

- (a) A wage claim may be filed in person at an office of the Commission, by mailing the claim to an address designated by the Commission, by faxing the claim to a fax

1 number designated by the Commission, or by electronic submission by way of web-  
2 based submission points identified through the Commission's Internet pages relating  
3 to filing a wage claim.  
4

- 5 (b) A wage claim must be filled out completely, legibly, and sufficiently to identify and  
6 allow the Commission to attempt contact with the employer.  
7

14 **§821.42. Timeliness.**  
15

- 16 (a) The Commission shall determine the filing date of a wage claim as the date delivered  
17 in person to the Commission, the date faxed to and received by the Commission at a  
18 fax number designated by the Commission, the date received by the Commission  
19 through electronic submission, or the date of a mailed wage claim based on the  
20 following:  
21

- 22 (1) The postmark date of a wage claim properly addressed shall establish by a  
23 rebuttable presumption, the date upon which the wage claim was filed unless  
24 the party opposing this presumption presents evidence to establish some other  
25 filing date.  
26  
27 (2) Absent a postmark or evidence establishing some other filing date, the date of  
28 receipt by the Commission shall control.  
29

- 30 (b) The Commission shall suspend the time limit for filing a wage claim only for those  
31 reasons required by law including, but not limited to, bankruptcy stays.  
32

31 (a) When authorized by §61.031 of the Act, the Commission may require a bond of an  
32 employer if the Commission reasonably believes the employer would otherwise fail  
33 to comply with the Act.

34  
35 (b) The Commission shall consider the following factors in determining the amount of  
36 the bond:

37  
38 (1) the seriousness of the violation, including nature, circumstances, extent and  
39 gravity of any prohibited acts;

40  
41 (2) the history of previous violations;

42  
43 (3) the amount necessary to deter future violations;

44  
45 (4) efforts to pay past due wages and penalties;

1 (5) the total amount of wages not paid in accordance with the Act; and

2  
3 (6) any other matter that justice may require.

4  
5 (c) The bond shall be in an amount not less than the cumulative total amount of wages  
6 finally determined to be due and unpaid by the employer in the past. The maximum  
7 bond shall be in an amount not more than five times the cumulative total amount of  
8 wages finally determined to be due and unpaid by the employer in the past.
